Notice of Xiamen Municipal People's Government on Implementing Temporary Regulatory and Control Measures over Ships in Waters of the Port Area of Xiamen Bay during the Major International Event

In order to ensure the success of the major international event, in accordance the *Decision of Fujian Provincial People's Government on Implementing Temporary Regulatory and Control Measures during the Major International Event (SZFL No.187)*, the *Decision of Xiamen Municipal People's Government on Reinforcement of Control over Dangerous Articles (XF [2017] No.212)* and the *Decision of Xiamen Municipal People's Government on Reinforcement of Public Security Administration at Sea (XF [2017] No.248)*, it is decided to take temporary regulatory and control measures over ships entering the waters of Port Area of Xiamen Bay during the major international event, and here release the notices as follows:

- I. During the period from 0000hrs on 1 September 2017 to 2400hrs on 6 September 2017, ships entering the waters of Port Area of Xiamen Bay are prohibited from using fuel oil with sulfur content over 0.5%.
- II. Except for the need of national economy and the people's livelihood, during the period from 0000hrs on 20 August 2017 to 2400hrs on 26 August 2017, oil tankers, chemical tankers, liquefied gas carriers and ships carrying packaged explosives, flammable gases and liquids, oxidizing substances and organic peroxides, self-reactive substances, highly toxic products, infectious substances and radioactive substances are prohibited from entering into or departing from the waters of Port Area of Xiamen Bay; during the period from 0000hrs on 27 August 2017 to 2400hrs on 6 September 2017, operations of loading and discharging dangerous goods are prohibited within the Port Area of Xiamen Bay, and ships carrying dangerous goods other than those classified as Class 8 (corrosive substances) and Class 9 (miscellaneous dangerous substances and articles) are prohibited from entering into or departing from the waters of Port Area of Xiamen Bay.
- III. During the period from 0000hrs on 27 August 2017 to 2400hrs on 6 September 2017, the operations of yachts and sailboats in Xiangshan Yacht Terminal in Siming District will be suspended.

- IV. During the period from 0000hrs on 1 September 2017 to 2400hrs on 6 September 2017, the operation of the “Visiting Kinmen at Sea” tourism shipping line will be suspended.
- V. During the period from 0000hrs on 1 September 2017 to 2400hrs on 6 September 2017, ferries are prohibited from sailing in night, except for the need of the people’s livelihood.
- VI. During the period from 0000hrs on 27 August 2017 to 2400hrs on 6 September 2017, the operation of passenger shipping lines for which real-name administration system or source/destination security checks cannot be implemented will be suspended.
