Re: Prevention of the risk of invasion of bed bugs

Exceptional actions for the control and inspection of vessels

Ref: Ministerial Circular N°16908 dated 4 October 2023

Within the scope of the actions for the prevention of the risk of invasion of bed bugs covered by the captioned Circular, I attach herewith two technical forms regarding the organisation of an inspection of a vessel coming from a French port and the list of insecticides to be used in case of need, in order to harmonize the required interventions.

A short report must be made after each inspection and a weekly activity report must be communicated to the hierarchy and the Directorate of Epidemiology and Disease Control.

Prevention of the risk of invasion of bed bugs

Technical and organisational procedure for the inspection of vessels coming from French ports

- I . Upon departure of the vessel from the port of origin, the ship agent must send the following documents:
 - 1. The maritime health declaration;
 - 2. The crew list;
 - 3. The list of passengers;
 - 4. The list of the 10 previous ports;
 - 5. The certificate of disinsection.
- II. The vessel must stay at the waiting anchorage and the health officers must go to the ship, in perfect coordination with the port authorities.
- III. The control and inspection at the waiting anchorage, including the following actions:
 - 1. The control of the documents listed above;
 - 2. The control of the medical chest on board;
 - 3. The thorough inspection of all the accommodation areas of the vessel as follows:

Direct visual detection: presence of moulting, eggs, larvae or adult insects		
Indirect visual detection: bites or presence of blood stains		
Indirect detection with the aid aof a UV lamp: dejections or blood stains		

IV. Assessment of the risk at the end of the inspection

Stage 3	Detection of bugs in other rooms	Important infestation	The prohibition of the disembarking of passengers and discharging of cargo should be contemplated	
Stage 4	Detection of bugs in all the ship's accommodation areas	Critical infestation		

V. Upon completion of each operation: the health officers must issue an inspection report according to the attached template, and send it to the central unit for boarder health control (DELM) and the administrative hierarchy.
