Cover

The increased reliance on wind-generated electricity is well documented and set to expand. Generating clean energy from offshore turbines plays an important role in this. Construction of offshore wind farms relies on highly specialised installation craft which are usually purpose built. Other types of offshore supply vessels may also be involved and used for the purpose of personnel transport, cargo transport, diving support, maintenance and other related activities.

In addition to the vessels' standard mutual P&I cover, wind farm installation and support vessels will usually require Extended P&I cover for Specialist Operations due to the nature of the work being undertaken. This additional cover protects Members from normal P&I risks (as set out in Rule 2 of the Club's Rules) arising out of the specialist nature of the operations.

Wind farm projects commonly involve EPC or other turnkey contracts adapted from industry standard construction contracts such as FIDIC. Although there are some sector specific contracts coming online, such as BIMCO Windtime, these do not tend to be suitable for offshore wind farm construction projects. As such, the contracts the UK Club typically sees from its Members are bespoke, often comprehensively negotiated, and can see Members retain a much greater risk profile than their contracting counterparty. The UK Club is able to respond to Members' contractual liabilities through its Extended Contractual Liability cover, which provides protection for third party personal injury or property damage, contractually assumed wreck removal liabilities, and allows naming of project partners as additional assureds whilst waiving rights of subrogation against them. The Club's contract review team, headed up by the Offshore & Contracts Director, has extensive experience of reviewing offshore construction contracts, and will provide a clear, concise summary of the impact that contract provisions have on P&I cover.



P&I cover for the global offshore wind industry

We insure Members involved in the full spectrum of operations in the offshore wind industry: from charterers engaged in the initial core sampling operations, to owners of units engaged in turbine installation (WTIVs), as well as operators of crew transfer vessels (CTVs) and walk-to-work units. Our Mutual P&I and Charterers Liability Cover will also respond to liabilities of owners and operators engaged in the global shipment of wind turbines and equipment.

Seabed investigation & preparation

We insure owners and charterers of units engaged in investigation and preparation work on behalf of wind farm owners and developers. This ranges from seismic survey work utilising streamers to the use of ROVs and similar equipment for deep water operations. Our additional cover extends to the liabilities incurred when operating this underwater equipment.

Trenching & cable laying

Our entered vessels include several cable laying and trenching units, whether traditional vessels or those utilising remotely operated equipment developed specifically for this activity. We can provide our Members with specialist operations cover, underwater operations cover and contractual liability cover uniquely tailored to the projec tin which they are engaged.

Transport of components

We provide charterers liability insurance, typically purchased by manufacturers of wind turbines and wind turbine components who supply third party wind farm developers or use the equipment for their projects globally. Our fully comprehensive P&I cover, specific to charterers and the particular liabilities they incur, can be extended to include Cargo Owner/Trader Extension Cover (in respect of cargo carried on an entered ship). The UK Club can also provide cover to mutual owned Members whether they are fulfilling global transport contracts or delivering equipment to an offshore wind farm as part of a construction contract.

Installation

The Club is a leading insurer of craft engaged in offshore wind farm construction and installation. We cover purpose built wind farm installation vessels as well as well as wind farm owners chartering in craft to assist with maintenance or other types of vessels involved in the operations, such as supply ships, those used for personnel transport, cargo transport, diving support, maintenance and other related activities.
